- ONE:** The name of this corporation is the Nevada Gay Rodeo Association (N.G.R.A.).

THREE: The objective and purpose for which this Corporation is organized and the nature of the business to be carried out by it are as follows:

- a. To act as a Non-Profit Organization, as defined by the State of Nevada under Chapter 82, Non-Profit Corporations;
- b. To be an Association of members who share a common interest in rodeo, equestrian events, and/or western lifestyles, with entertainment activities for civic, education and/or charitable purposes;
- c. To perform charitable duties for the surrounding area through fund raising, rodeo performances, etc., for any particular legally recognized charitable organization the General Membership of the organization choose;
- d. To do any and all things necessary, suitable and proper to conduct the business and carry out the objectives herein expressed, including but not restricted to those expressly conferred upon Non-Profit Corporations by the laws of the State of Nevada, as well as those necessarily implied; and
- e. To have and to exercise all the powers now and hereinafter conferred by the Laws of the State of Nevada upon Non-Profit corporations organized pursuant to the Laws under which the Corporation is organized and any and all acts amendatory thereof and supplementary thereto and to engage in any other lawful activities.

FOUR: The members of the governing board are directors of the corporation and the number of Directors is not to exceed nine. The corporation reserves the right to change the number of directors at any time necessary.
